4. Payment

7. Returns

The return of goods for credit account will only be accepted under the following circumstances;

- a) All returns to be approved by Westernex prior to return
- b) Goods to be returned to Westernex, freight paid within 7 days of approval

- e) Subject to a restocking fee

The following goods will not be accepted for credit;

- b) Products that have been brought specifically for the Customer
- c) Any product for which has been damaged or altered in any way

8. Price Disputes

Must be advised to Westernex within 14 days of invoice date, or price is deemed acceptable

9. Warranty

- a) No warranty is given by Westernex for goods not manufactured by Westernex. Westernex will, so far as it reasonably can, transfer or make over to the Customer the benefit of any guarantee or warranty which may have been given by another manufacturer of the goods.
- b) Notice of Claim of Warranty must be given to Westernex in writing.
- c) Approved goods to be returned to Westernex freight paid within 7 days of notification.

Westernex may by notice in writing to the Customer alter any of these terms and conditions.

10. Guarantee

In consideration of Westernex at our request providing goods on credit to the customer, each of the persons whose signatures appear below hereby, jointly and severally guarantee the payment by the Customer to Westernex of all outstanding amounts and indemnifies Westernex in respect of any loss it may suffer.
